PROCEDURAL ORDER

**BY THE COMMISSION:**

On June 3, 2005, as amended on June 17, 2005. Arizona-American Water Company ("Arizona-American") filed with the Arizona Corporation Commission ("Commission") an application for a determination of the current fair value of its utility plant and property and for increases in its rates and charges for utility service based thereon for utility service by its Paradise Valley Water District (Docket No. W-01303A-05-0405).

By Procedural Order issued August 15, 2005, a hearing was scheduled to commence on March 27, 2006 in Docket No. W-01303A-05-0405.

On December 22, 2005, Arizona-American filed with the Commission an application for approval of an agreement with Paradise Valley Country Club ("PVCC") which would allow PVCC a 15 percent discount from the Company's standard turf rates (Docket No. Docket No. W-01303A-05-0405). The Commission's Utilities Division Staff ("Staff") filed a Staff Report recommending approval of the application, and stating that Staff has no objection to consolidation of the above-captioned dockets.

1 IT IS THEREFORE ORDERED that Docket Nos. W-01303A-05-0910 and W-01303A-05-  
2 0405 shall be consolidated.

3 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,  
4 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at  
5 hearing.


