PROCEDURAL ORDER

BY THE COMMISSION:

On November 15, 2005, Green Acres Water, L.L.C. ("GAW") filed an application with the Arizona Corporation Commission ("Commission") for a Certificate of Convenience and Necessity ("Certificate") to provide water service.

On November 15, 2005, Green Acres Sewer, L.L.C. ("GAS") filed an application with the Commission for a Certificate to provide sewer service.

On December 9, 2005, the Commission's Utilities Division ("Staff") filed letters of insufficiency for GAW and GAS.

On March 1, 2006, Staff filed a Motion to Consolidate ("Motion") the above-referenced matters stating that the issues in the matters are substantially related and no parties' rights will be prejudiced by the Motion.

IT IS THEREFORE ORDERED that the above-referenced matters are hereby consolidated for purposes of hearing.


