MOTION TO INTERVENE

Pursuant to A.A.C. R14-3-105, Sulphur Springs Valley Electric Cooperative, Inc. ("Sulphur Springs") hereby applies to the Arizona Corporation Commission ("Commission") for an Order granting Sulphur Springs leave to intervene in the above-captioned proceeding.

1. Sulphur Springs is currently an all-requirements member of Arizona Electric Power cooperative ("AEPSCO"), and AEPSCO is a wholesale supplier of electricity to Sulphur Springs. For these reasons, Sulphur Springs will be directly and substantially affected by a Decision of the Commission in this proceeding.


