

On the 20th day of December 1999, the Division mailed via First Class mail a copy of the Notice of Supplemental Authority to Respondent James Charles Simmons, Jr. ("Simmons"), at his address of record 5045 North 58th Avenue #23A, Glendale, AZ 85301. This mailing was completed on the 21st of December 1999 when it was postmarked by the US Post Office.
