PROCEDURAL ORDER

BY THE COMMISSION:

On December 9, 1999, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("Temporary Order") and Notice of Opportunity for Hearing Regarding Proposed Order for Relief ("Notice") against Superior Leasing of Arizona, Inc. ("Superior"), Mr. Lloyd H. Rockwell and Mr. Michael R. French in which the Division alleged multiply violations of the Securities Act in connection with the offer and sale of securities in the form of promissory notes or investment contracts.

All Respondents named in the above-captioned proceeding were duly served with copies of the Notice, but only Superior and Mr. Rockwell requested a hearing.

On April 11, 2000, the Commission approved a Consent Order on this proceeding involving Respondents, Superior and Mr. Rockwell, who had requested a hearing.

Accordingly, the hearing scheduled for April 18, 2000, should be vacated.


