PROCEDURAL ORDER

BY THE COMMISSION:

On December 27, 1999, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order for Relief ("Notice") in which it was alleged that Mr. William K. McCrea and Estate Services II, Inc. ("ESI") committed multiple violations of the Arizona Securities Act.

On January 5, 2000, Mr. McCrea and ESI filed a Request for Hearing and Motion for a Pre-Hearing Conference.

On January 10, 2000, by Procedural Order a Pre-hearing Conference was scheduled for January 20, 2000.

On January 20, 2000, the Pre-Hearing Conference was held and it was agreed that a Status Conference would be scheduled for February 10, 2000.

On February 10, 2000, the parties discussed settlement and a hearing was scheduled for April 12, 2000.

On March 27, 2000, the parties filed a joint stipulation which indicated that the Division and the Respondents were planning to enter into a Consent Order and requested that the hearing date be vacated pending the submission of the Consent Order for Commission approval.

Accordingly, the hearing date should be vacated.

1 IT IS THEREFORE ORDERED that the hearing scheduled for April 12, 2000, be, and is
2 hereby, vacated.

3 IT IS FURTHER ORDERED that the Division shall request that the proceeding be
4 rescheduled for hearing if the Consent Order is not approved by the Commission.
