
The Securities Division ("Division") of the Arizona Corporation Commission hereby requests that the hearing in S-03312A, currently scheduled for December 6, 1999, be continued to a date to be determined at the Pre-Hearing Conference scheduled on December 2, 1999, for the following reasons: the Division has filed a Motion to Consolidate case S-03312A with case S-03375A; Respondent John Ebdon in S-03312A has requested a hearing and no hearing date has been scheduled; Respondent Daniel Joe Garcia in S-03375A has requested a hearing and no hearing date has been scheduled; and Respondent Carol Ebdon Garcia in S-03375A has not yet requested a hearing.

1 Last Wednesday afternoon undersigned counsel spoke with Respondents Shull, who is also the  
2 President/CEO and sole director of Respondent Cochise Financial Corp., and Respondent Ebdon. None  
3 of these Respondents have any objection to S-03312A being consolidated with S-03375A and to the  
4 hearing in S-03312A being continued from December 6, 1999, to a later date.

5 The Division is preparing for the hearing in S-03312A set for December 6, 1999, and requests  
6 an expedited ruling on this motion so the Division can utilize its resources more wisely if the hearing is
