9 **BY THE COMMISSION:**

10 On February 1, 2001, the Arizona Corporation Commission ("Commission") issued Decision
11 No. 63321 in the above-captioned matter. As part of the Decision, the Commission ordered that a
12 hearing be scheduled regarding the supplemental proposed rule making. Pursuant to those directions,
13 this Procedural Order establishes a hearing schedule.

21 before April 5, 2001.
