PROCEDURAL ORDER

BY THE COMMISSION:

On August 24, 1999, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order for Relief, naming Respondents Charles Shull, John Ebdon, and Cochise Financial Corp. ("Cochise").

On September 9, 1999, Respondents Shull and Cochise filed with the Commission requests for a hearing, requesting a hearing pursuant to A.R.S. § 44-1972 and A.A.C. R14-4-306. Respondents Shull and Cochise requested that the hearing "not be scheduled earlier than 60 to 90 days" from the date of the request, due to recent health problems of Respondent Shull.

Due to the normally short timeline for hearings, it is necessary to set the hearing at this time. The hearing will be set in accordance with the wishes of Respondents Shull and Cochise, without prejudice to the Division if an objection to the hearing date is forthcoming.

IT IS THEREFORE ORDERED that the hearing as to the allegations against Respondents Shull and Cochise Financial Corp. in the above-captioned matter shall commence on **December 6, 1999, at 9:30 a.m.**, or as soon thereafter as is practical, at the offices of the Arizona Corporation Commission, 1200 West Washington Street, Phoenix, Arizona 85007.

1 IT IS FURTHER ORDERED that the Securities Division shall file any objection to the delay
2 in the hearing on or before September 21, 1999.

3 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
4 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
