PROCEDURAL ORDER

BY THE COMMISSION:

On July 24, 2000, the Arizona Corporation Commission ("Commission") issued Decision No. 62735 in the above-captioned matter. As part of the Decision, the Commission ordered that a hearing be scheduled regarding the proposed rule making. Pursuant to those directions, this Procedural Order establishes a hearing schedule.

On August 1, 2000, by Procedural Order, the Commission scheduled a public comment hearing for September 26, 2000, and ordered the Securities Division ("Division") to provide notice of the proposed rulemaking in the Arizona Administrative Register.

On September 13, 2000, the Division filed a Motion to Continue ("Motion") the hearing indefinitely in order to allow the Division time to address the concerns of members of the Canadian regulatory community and securities industry that would be affected by the proposed rulemaking.

Accordingly, the proceeding should be continued indefinitely.

IT IS THEREFORE ORDERED that the hearing scheduled in the above-captioned proceeding shall be continued indefinitely and all filing requirements for responses to comments shall be suspended if not previously filed.
