12 **BY THE COMMISSION:**

13 Having considered the entire record herein and being fully advised in the premises, the
14 Commission finds, concludes, and orders that:

15 **FINDINGS OF FACT**

16 1. On February 21, 2002, Amir Contractor ("Applicant") filed with the Commission an
17 application for a Certificate of Convenience and Necessity ("Certificate") to provide customer-owned
18 pay telephone ("COPT") service in the State of Arizona.

19 2. In Decision No. 55817 (December 10, 1987), the Commission found that COPT
20 providers were public service corporations subject to the jurisdiction of the Commission.

21 3. In Decision No. 57797 (April 8, 1992), the Commission adopted A.A.C. R14-2-901
22 through R14-2-909 to regulate COPT providers.

23 4. Decision No. 58535 (February 14, 1994) adopted a Generic Tariff that establishes
24 rates and minimum service standards applicable to COPT service.

25 5. Pursuant to A.R.S. § 40-282, the Commission may issue Decisions regarding COPT
26 Certificates without a hearing.

27 6. Applicant has requested that a Certificate be granted and has indicated that it will
28 provide COPT service pursuant to the rates, terms and conditions specified in the Generic COPT
Tariff.

ORDER

IT IS THEREFORE ORDERED that the Application of Amir Contractor for a Certificate of Convenience and Necessity for authority to provide customer-owned pay telephone service in Arizona shall be, and the same is, hereby granted.

IT IS FURTHER ORDERED that this Decision shall become effective immediately.
