16 Necessity ("Certificate" or "CC&N") as a long-distance reseller in Docket No. T-02584A-91-0016.

17 On December 1, 1995, Excel amended its application.

18 On December 1, 2000, Excel filed updated information in response to a request from the
19 Commission Utilities Division ("Staff").

20 On April 8, 2002, Excel filed an application for a CC&N as a facilities-based local exchange
21 carrier in Docket No. T-02584A-02-0268.

22 On May 3, 2002, Staff filed a Motion to Consolidate Excel's applications as Staff stated it is a
23 sound policy to review all pending CC&N applications for a company at the same time.


