19 On January 16, 1991, Excel Telecommunications, Inc., (Excel) filed an
20 application for a Certificate of Convenience and Necessity (CC&N) as a long distance
21 reseller, Docket No. T-02584A-91-0016. On December 1, 1995, Excel filed an amended
22 application. On December 1, 2000, Excel filed updated information in response to a
23 request from Staff. No Staff Report or Recommended Opinion and Order has been
24 issued in Docket T-02584A-91-0016. On April 8, 2002, Excel filed an application for a
25 CC&N as a facilities-based local exchange carrier, Docket No. T-02584A-02-0268. It is
26 sound policy to review all pending CC&N applications for a company at the same time,
27 so that the "whole picture" is considered. Moreover, in this case the 2002 application

1 contains much more recent information concerning Excel. Accordingly, Staff moves that
2 Dockets T-02584A-91-0016 and T-02584A-02-0268 be consolidated.
