Dear Mr. Dion,

This letter acknowledges our telephone conversation on April 25, 2002. We reviewed the two different Staff Reports regarding the requirement of a performance bond and the change of our registered agent with the Arizona Corporation Commission.

- **Review of Financial Information:** The Staff Report of February 26, 2002, page 2, states that ProNet Communications, Inc. is not required to have a performance bond as we do not collect deposits, advances or prepayments of any kind, as stated in our tariff, Section 2.7.3 on page 13. On March 6, 2002 we have a Staff Report stating that we are required to have a performance bond as the tariff states that we do collect deposits. Months ago the first copy of the tariff, issue date June 7, 2001, filed August 13, 2001 did state we would collect deposits, so that may be the source of the conflicting information. The entire application and tariff, issue date August 6, 2002, was resubmitted. The second application appears to still carry the August 13, 2001 filing date. We received the March 6, 2002 Staff Report two weeks before we received the February 26, 2002 Staff Report. Until our phone conversation we did not notice the puzzling dates. We assumed that the February 26 Staff Report was the most recent, because of the arrival time and because it accurately reflected our tariff. We wondered if the February 26, 2002 was to have been dated March 26, 2002.
- **Change of Registered Agent:** On April 15, 2002 we changed our Resident Agent in Arizona. The new agent is National Registered Agents, Inc., 302 North First Avenue, Suite 440, Phoenix, AZ 85003. Enclosed are copies of the stamped documents from the Arizona Corporation Commission, Corporations Division.

Thank you for your assistance in this matter.
