To The Commission:

AT&T Communications of the Mountain States, Inc., submits for approval and authorization of the Arizona Corporation Commission, two pages for filing in Teleport Communications Group (TCG Phoenix) Services Tariff and Price List. With this filing, TCG Phoenix is requesting approval for an increase in its Rate CAP for Directory Assistance.

Under separate cover in a supplemental filing, AT&T will provide the Utilities Division the revenue increase impact and the appropriate certification of customer notification prior to implementation of the proposed tariff change. The requested effective date for this filing is April 30, 2001.

Additionally, it has come to our attention that an error was made on a filing submitted by Teleport Communications Group (TCG) issued on October 21, 1998, and effective on November 23, 1998. TCG was attempting to reduce the Directory Assistance Rate on the Price List from \$.45 to \$.35. Inadvertently, the Directory Assistance Rate reduction was made on the Tariff page and not the Price List. This filing also corrects that error by changing the Price List to show the correct rate of \$.35.

**4.11 Directory Assistance**

Customers and Users of the Company's calling services (excluding 800 services), may obtain directory assistance in determining telephone numbers within Arizona by calling the Directory Assistance operator.

Directory Assistance charges apply for all requests for which the Company's facilities are used. Each number requested is charged for as shown below. Requests for information other than telephone numbers will be charged the same rate as shown for the applicable request for telephone numbers.

A Directory Assistance call charged to a calling card or commercial calling card or to a third number will be billed the appropriate operator charge, as specified in this tariff, plus the charge for Directory Assistance.
