McLeodUSA Telecommunications Services, Inc. ("McLeodUSA") requests an Amendment to Tariff No. T-03267A-02-0500, that was originally filed on July 2, 2002. McLeodUSA hereby transmits for filing an original and ten copies of the Amended Page No. 61 to replace our previous Page No. 61 (filed on July 18, 2002) to its Arizona Tariff C.C. No. 2.

The purpose of this tariff revision, (Docket No. T-03267A-02-0500), was to mirror the increase of Qwest's Local and National Directory Assistance ("DA") Direct Dial rates. The July 18, 2002 Amendment replaced Page No. 61 to reflect the increase of the 'National Directory Assistance-direct dialed' current rate, which had been omitted from Page No. 61 in the original request (filed July 2, 2002). This Amendment replaces Page No. 61 to reduce the 'maximum' rate for the "Direct dial call" from \$1.15 to \$1.11, which will now mirror our current rate. Consequently, the 'current' and 'maximum' rates for "Direct dial call," listed on "Rate Table 3: Directory Assistance Rates" are the same amount.

The tariff still reflects an issue date of June 14, 2002 and an effective date of July 20, 2002. However, this tariff will not be effective until approved by the ACC.
