McLeodUSA Telecommunications Services, Inc. ("McLeodUSA") hereby transmits for filing an original and 13 copies of the following responses to the request from the Arizona Corporate Commission. Please file stamp the extra copy and return it to me in the enclosed, self-addressed, stamped envelope.

McLeodUSA submitted a tariff revision changing the rate for Directory Assistance Direct Dial Call ("Local Directory Assistance") to our tariff dated July 2, 2002 (Issue Date), which was assigned Docket No. T-3267A-02-0500. Marta Kalleberg from the Arizona Corporate Commission responded, in a letter dated November 6, 2002, that McLeodUSA needed to supply additional information for review by the Commission within 10 business days, November 20, 2002. The request and response follow:

1. What are the rates charged by McLeodUSA for this service (or substantially similar services) in other Western states? If McLeodUSA does not serve any other Western states, then please provide the rates charged by McLeodUSA for the service in all other states it serves. If McLeodUSA only serves Arizona, please indicate that.

The current Local Directory Assistance rates charged in other Western states, (where Qwest is the ILEC) are as follows:



* Qwest increased their Local Directory Assistance Call rate in Arizona and New Mexico. McLeodUSA's proposed increase in Arizona mirrors Qwest's new Local rates for both current and maximum amounts.

** The new Local Directory Assistance rate for New Mexico is \$0.66, (effective June 3, 2002) which mirrors the Qwest Local Directory Assistance rate in New Mexico.
