McLeodUSA Telecommunications Services, Inc. ("McLeodUSA") requests an Amendment to Tariff No. T-03267A-02-0445, that was originally filed on June 14, 2002. McLeodUSA hereby transmits for filing an original and ten copies of the Amended Page No. 52.1 to replace our previous Page No. 61 (filed on June 14, 2002) to its Arizona Tariff C.C. No. 2.

The purpose of this tariff revision, (Docket No. T-03267A-02-0445), was to add language regarding "Bill Copies" to our tariff. Page No. 52.1 that was originally submitted reflected the current prices only, and did not include the maximum prices. We discovered the omission of the 'maximum' pricing amounts when Marta Kalleberg, from the ACC, notified us of the inconsistency from our support documentation (submitted on July 3, 2002), which did include the current and maximum pricing. Consequently, this Amended Page No. 52.1 also reflects the 'maximum' pricing under "4.1.6 Billing Copies" that was previously omitted from the original filing.

The tariff still reflects an issue date of June 14, 2002 and an effective date of July 20, 2002. However, this tariff will not be effective until approved by the ACC.
