AMEND ORDER

Navopache seeks an amendment to Decision No. 65532 to increase the term of the loan and to make certain other technical corrections. Decision No. 65532 approved a 20 year loan term, as requested in the Application. See Application at ¶ 11. Navopache now seeks a 35 year term. Staff supports Navopache's Motion. The revised order can be adopted pursuant to A.R.S. § 40-252. A hearing would not be useful in resolving this uncontested matter. Accordingly, Navopache should file a statement waving its right to a hearing under A.R.S. § 40-252. Navopache's Board Resolution approved a 20 year term. See Application at Exhibit B. Accordingly, Navopache should be required to submit a revised Board resolution prior to consideration of an amended order.


