**STAFF'S OPPOSITION TO SUN CITY COMPANIES'  
REQUEST FOR PROCEDURAL ORDER**

The Arizona Corporation Commission Staff ("Staff") hereby opposes Sun City Companies' Request for Procedural Order that would set up the following schedule:


1. Staff and Intevenors file testimony by July 1, 1999;
2. Sun City Companies file rebuttal testimony by August 5, 1999;
3. Hearing to commence in late August.

This docket contains a voluminous amount of information in both the applications filed by the company, as well as the company's responses to staff's data requests. To adequately analyze this information and make proper recommendations, Staff requests an alternative schedule as follows:

1. Staff and Intervenors filed direct testimony on or before September 1, 1999;
2. Sun City Companies file rebuttal testimony and supporting exhibits on or before October 4, 1999;
3. Staff and Intervenors file surrebuttal testimony on or before October 18, 1999;
4. Sun City Companies file rejoinder testimony, if any, no later than three days before the hearing.

1 In conclusion, Staff requests that the Hearing Officer issue a procedural order to govern  
2 this proceeding and to set a hearing date.


