BY THE COMMISSION:

On October 1, 1998, Sun City Water Company and Sun City West Utilities Company (collectively "Sun City Companies") filed with the Arizona Corporation Commission ("Commission") an application for approval of the Central Arizona Project water utilization plan and for an accounting order authorizing a groundwater savings fee and recovery of deferred CAP expenses.

On June 3, 1999, the Sun City Companies filed a Request for Procedural Order ("Request").

On June 11, 1999, Commission Staff ("Staff") and the Residential Utility Consumer Office ("RUCO") filed oppositions to the Request, and proposed alternate procedural schedules.

On June 14, 1999, the Sun City Taxpayer's Association, Inc. ("SCTA") also filed its response to the Request.

On June 15, 1999, the Sun City Companies filed a Response to Objections to the Request.

IT IS THEREFORE ORDERED that the hearing shall commence on October 13, 1999 at 10:00 a.m., or as soon thereafter as is practicable, at the Commission's offices, 1200 W. Washington Street, Phoenix, Arizona.

IT IS FURTHER ORDERED that Staff and Intervenors shall file and provide copies of their direct testimony to all parties, no later than noon on September 10, 1999.

IT IS FURTHER ORDERED that the Sun City Companies shall file and provide copies of

1 their rebuttal testimony to all parties, no later than noon on September 24, 1999.

2 IT IS FURTHER ORDERED that Staff and Intervenors shall file and provide copies of their
3 surrebuttal testimony to all parties, no later than noon on October 1, 1999.

4 IT IS FURTHER ORDERED that the Sun City Companies shall file and provide copies of
5 their rejoinder testimony to all parties, no later than noon on October 8, 1999.


