STAFF'S WITHDRAWAL OF MOTION FOR EXTENSION OF TIME

On October 1, 1998, Sun City Water Company and Sun City West Utilities Company (collectively "Sun City Companies") filed with the Arizona Corporation Commission ("Commission") an application for approval of the Central Arizona Project ("CAP") water utilization plan and for an accounting order authorizing a groundwater savings fee and recovery of deferred CAP expenses.

Staff and intervenors filed direct testimony on September 10, 1999.

Sun City Companies filed rebuttal testimony on September 24, 1999.

Staff's surrebuttal testimony was due on October 1, 1999. Due to the significant revisions by Mr. Dabelstein, Staff believed additional discovery was needed and requested a three-week continuance.

Staff has subsequently discussed said revisions with Mr. Dabelstein and has reconciled most of the discrepancies. At this time Staff requests an extension to file surrebuttal testimony until October 5, 1999. Further, Staff agrees to give Sun City Companies an opportunity to supplement their rejoinder testimony in response to Staff's surrebuttal testimony. Staff has contacted the company and all intervenors in this matter. No objections to these requests have been made. As a result, the requested continuance will not be necessary and Staff withdraws its motion to continue.

1 Staff respectfully requests that the hearing officer allow Staff to file surrebuttal testimony
2 on or before October 5, 1999 and allow Sun City Companies to supplement their rejoinder testimony
3 in response to Staff's surrebuttal testimony.
