
The Arizona Corporation Commission (“Commission”) is currently reviewing the above referenced applications for Certificates of Convenience and Necessity in Mohave County, Arizona and would appreciate it if you would provide the following information to the Commission:

1. Please provide a list of all known projects utilizing groundwater that are planned in Mohave County?
2. Please identify which aquifer(s) the projects would affect.
3. Please provide an explanation of the competing projects in relation to issuance of a water adequacy reports. Please include discussion of the Ranch at White Hills (by Mr. & Mrs. Leonard Mardian), the Village at White Hills & Golden Valley South (by Rhodes Development), and any other entities that you are aware of that have requested to obtain water adequacy reports or increase its use of water e.g. Mineral Park Mine in Mohave County.
4. Has any aquifer wide study been done or envisioned by Arizona Department of Water Resources (“ADWR”) for the areas in question? Please explain. If a study has been done, please provide a summary of the findings and conclusions.
5. Please describe ADWR’s requirements for recharge and recovery of effluent and how effluent credit is applied outside an active management area.
