RE: Proposed sewer increase by Far West Water and Sewer Company

To Whom it May Concern:

As a property owner of two RV lots, in the Foothills area of Yuma AZ, and snowbirds ' from Washington, we are opposed to the sewer increase being considered by the commission. We are currently paying \$20.00 per month year around if we are in residence and the water is turned on or not. As residents from 4 to 6 months of the year, the sewer is not being utilized when there is no water turned on. Previously the sewer rate was imposed only when we were here and the water was turned on.

I feel this increase is in response to the recent lawsuit and judgement by the courts. Because of the recent ruling by the courts, Far West Water and Sewer and Water will probably, in the near future, petition the commission for an increase in water rates. Which the company also governs the rates.

This company has a monopoly on the water and sewer in the Foothills area so we do not have a choice of providers for this service. It is very convenient for the company to request and the commission to agree to the scheduling of a public hearing in the middle of July when a large number of property owners are not in the area. This would be virtually impossible for many to attend the hearing, including us.

In short I am adamantly opposed to the increase in sewer rates by Far West Water and Sewer.
