RE: **APPLICATION WITHDRAWAL - IN THE MATTER OF THE REQUEST OF ALLTEL COMMUNICATIONS, INC. FOR WITHDRAWAL OF ITS APPLICATION FOR A CERTIFICATE OF CONVENIENCE AND NECESSITY. (DOCKET NO. T-03887A-00-0386)**

On August 9, 2001, ALLTEL Communications, Inc. ("ACI") submitted correspondence indicating the desire to withdraw its application for a CC&N to provide competitive resold interexchange telecommunications services (Docket no. T-03887A-00-0386). On October 30, 2000, ACI and 360° Long Distance, Inc. ("360°") filed an application to transfer assets held by 360° to ACI (Docket No. T-03285A-00-0874). 360° was given a CC&N in Decision No. 62280. In the transfer of assets application, ACI stated that it would operate under the CC&N of 360° once the transfer was approved. The Commission granted the application to transfer assets on August 6, 2001, in Decision No. 63937. The Decision ordered that ACI withdraw its application for a CC&N within 30 days of the effective date of the Decision. This August 9, 2001, filing by ACI is in compliance with the Decision granting the transfer of assets. Therefore, Staff has no objections to this request, and this matter (T-03887A-00-0386) should be withdrawn.
