PROCEDURAL ORDER

Respondents.

BY THE COMMISSION:

On December 13, 2005, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and a Notice of Opportunity for Hearing ("Notice") against Michael Giannantonio (a/k/a Michael David Turley), individually and doing business as Nitefire Entertainment ("Nitefire"), and Karen Lynn Turley, husband and wife, John Voight and Jane Doe Voight, husband and wife, Nitefire, a sole proprietorship, and SummitSTAR Entertainment, L.P., and Arizona limited partnership, doing business as SummitSTAR Films and/or SummitSTAR Films & Entertainment ("SummitSTAR") (collectively the "Respondents") in which the Division alleged multiple violations of the Arizona

1 Securities Act ("Act") in connection with the offer and sale of securities in the form of investment  
2 contracts.

3 Respondents Michael Giannantonio (a/k/a Michael David Turley) and Karen Lynn Turley and  
4 the above-named business entities were duly served with copies of the T.O. and Notice.

5 On February 21, 2006, the Division dismissed its action against John and Jane Doe Voight.

6 On March 2, 2006, during the Commission's regularly scheduled Open Meeting, a Default  
7 Order against the Respondents was presented by the Division. At that time, Mr. Michael  
8 Giannantonio appeared telephonically stating that a response to the T.O. and Notice was to have been  
9 filed. The Commission deferred action on the Default Order and gave the Respondent additional  
10 time to e-mail a response to the allegations in the T.O. and Notice.

11 On March 10, 2006, a response was filed by Respondents generally denying the allegations in  
12 the T.O. and Notice.


13 On March 15, 2006, by Procedural Order, a pre-hearing conference was scheduled for April 6,  
14 2006.

15 On April 6, 2006, the Division and Respondents appeared through counsel. Counsel for  
16 Respondents agreed to file a request for hearing and a formal Answer within ten days. The Division  
17 and counsel for Respondents agreed to attempt to reach a resolution of the proceeding and further  
18 agreed that an additional pre-hearing be scheduled in approximately 60 days.

19 Accordingly, a pre-hearing conference should be scheduled to review the status of the  
20 proceeding.

21 IT IS THEREFORE ORDERED that a **pre-hearing conference** shall be held on **June 20,**  
22 **2006, at 9:30 a.m.**, at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.
