PROCEDURAL ORDER

BY THE COMMISSION:

On April 4, 2006, the Arizona Department of Transportation ("ADOT") filed with the Arizona Corporation Commission ("Commission") a request for approval for the Union Pacific Railroad ("Railroad") to upgrade a crossing at the I-10 Frontage Road at Ina Road, M.P. 974.0, in Marana, Pima County, Arizona at AAR/DOT No. 741-101-G.

IT IS THEREFORE ORDERED that the request of the Arizona Department of Transportation shall be considered an application for the Railroad to construct a new public railroad crossing pursuant to A.R.S. § 40-337, et seq.

IT IS FURTHER ORDERED that the **hearing** on the application shall be held on **May 18, 2006, at 10:30 a.m.**, or as soon thereafter as is practical, at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.




