Qwest Corporation, ("Qwest") hereby amends its Application for Arbitration Procedure and Approval of Interconnection Agreement by the removal of Pac West Telecomm Inc., Western Wireless Corporation, Smith Bagley Inc., and Star Page Inc.

Pac West Telecomm Inc. and Western Wireless Corporation represent to Qwest that they have no Wireless Type 1 service, and no paging service, requiring interconnection with Qwest in the State of Arizona.

Smith Bagley Inc. and Star Page Inc. have signed the appropriate interconnection agreements, or are in the process of signing and returning the agreements to Qwest. Qwest will file

1 those agreements for approval under Section 252 of the Telecom Act.

2 Accordingly, Qwest removes Pac West Telecomm Inc., Western Wireless Corporation,  
3 Smith Bagley Inc., and Star Page Inc. from its Application without prejudice, and requests that the  
4 caption of the proceeding be amended accordingly. Qwest's Application is not amended in any  
5 other respect.
