PROCEDURAL ORDER

BY THE COMMISSION:

On April 7, 2006, the Arizona Corporation Commission ("Commission") issued a Recommended Opinion and Order ("ROO") in the above captioned arbitration. The ROO gave the parties until April 17, 2006 to file exceptions.

On April 11, 2006, Level 3 Communications ("Level 3") filed a Motion for Extension of Time to File Exceptions. Level 3 did not receive the ROO until April 10, 2006, and given the length and complexity of the ROO requested an extension until April 24, 2006 to file exceptions.

On April 12, 2006, Qwest Corporation ("Qwest") filed a Response to Level 3's Motion. Qwest did not oppose an extension, but argued that the filing deadline should be April 21, 2006, to give Qwest and the Commission sufficient time to review and analyze the exceptions.

On April 13, 2006, Level 3 filed an Objection to Quest's Response, and argued that April 24, 2006 provides adequate time for review of any exceptions.

Given the complexity of the ROO, the extension request is reasonable. The matter is scheduled for the May 2, 2006 Open Meeting. A deadline for exceptions on April 24, 2006, would give all parties a week to review any exceptions, which we believe would be adequate.


