PROCEDURAL ORDER

BY THE COMMISSION:

In Decision No. 68119 (September 9, 2005), the Arizona Corporation Commission (“Commission”) approved the application of Arizona Water Company (“AWC” or “Company”) for an extension of its Certificate of Convenience and Necessity at its Oracle System. The Decision ordered AWC to file in Docket Control a copy of the developer’s Approval to Construct for the facilities required to serve the extension area within 365 days of the effective date of the Order.

On February 24, 2006, AWC filed a Request for Additional Time to Comply with Filing Requirement. AWC filed a copy of the Certificate of Assured Water Supply for the development, but requested an additional year to comply with the requirement to file the Approval to Construct. AWC reports that the developer encountered an unexpected planning delay and will not be ready to proceed with development until 2007.

On March 20, 2006, Commission Utilities Division Staff (“Staff”) filed a Memorandum that indicates Staff has no objection to a 365 day extension to file the Approval to Construct.

AWC has shown good cause for the requested extension.

IT IS THEREFORE ORDERED the deadline in Decision No. 68119 for filing the developer’s Approval to Construct shall be extended until September 9, 2007.


