PROCEDURAL ORDER

BY THE COMMISSION:

On October 6, 2005, Utility Source, L.L.C. ("Company" or "Applicant"), filed an application for an extension of its Certificate of Convenience and Necessity ("Certificate") with the Arizona Corporation Commission ("Commission") to provide public water and wastewater utility service to various parts of Coconino County, Arizona.

On April 7, 2006, Bellemont Development Co. filed an application to intervene. There has been no objection to the request.

IT IS THEREFORE ORDERED that the application to intervene by Bellemont Development Co. is hereby granted.

IT IS FURTHER ORDERED that the hearing on the application shall take place as previously ordered on April 26, 2006, at 9:30 a.m. at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona, unless otherwise ordered.

IT IS FURTHER ORDERED that the presiding Administrative Law Judge may rescind, alter, amend, or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


