PROCEDURAL ORDER

10 **BY THE COMMISSION:**

11 On March 18, 2002, SLV Properties, L.L.C. ("SLV" or "Complainant") filed with the Arizona  
12 Corporation Commission ("Commission") a Complaint against Arizona Water Company ("AWC" or  
13 "Respondent") alleging that AWC was in negligent in providing service to the Complainant.

14 On March 28, 2002, Respondent filed an Answer to the allegations of the Complaint.

15 On April 3, 2001, by Procedural Order, a pre-hearing conference was scheduled for April 18,  
16 2002.

17 On April 5, 2002, AWC filed a Motion to Continue the pre-hearing. Complainant has no  
18 objection to this request.

19 On April 11, 2002, by Procedural Order, the pre-hearing was continued to May 2, 2002.

20 On May 2, 2002, a pre-hearing conference was held with representatives of SLV and the  
21 Respondent present. Issues involved in the proceeding were discussed and the parties agreed to  
22 attempt to resolve the Complaint. They further agreed to a teleconference on June 4, 2002, to review  
23 the Complaint's status.

24 On June 4, 2002, the parties were unable to resolve the Complaint. Prior to a hearing being  
25 set, SLV requested time to consult with counsel and agreed to notify the Commission within 30 days  
26 as to when it could go forward with its Complaint.

27 Accordingly, a 30 day continuance should be granted before the Complaint is set for hearing.

1 IT IS THEREFORE ORDERED that a 30 day continuance shall be granted to SLV prior to a  
2 hearing being scheduled.

3 IT IS FURTHER ORDERED that SLV or its counsel shall contact the presiding  
4 Administrative Law Judge not later than July 5, 2002 to have the proceeding scheduled for hearing.


