PROCEDURAL ORDER

BY THE COMMISSION:


By Procedural Order dated September 11, 2000, the Arizona Corporation Commission ("Commission") established procedural guidelines in this matter, including a time frame for Lyxom, Inc. ("Applicant") to file fair value rate base ("FVRB") information. On November 9, 2000, Applicant filed a request for an extension for filing its FVRB information. No party opposed Applicant's request. Under the circumstances, Applicant's request is reasonable, and should be granted. In addition, the time clock set forth in A.A.C. R14-2-1103 should be extended.

IT IS THEREFORE ORDERED that Applicant shall file its FVRB information and rates and charges as set forth in the September 1, 2000 Procedural Order by February 5, 2001.

IT IS FURTHER ORDERED that Staff shall review the FVRB information and file comments within 30 days of receiving Applicant's FVRB information.

IT IS FURTHER ORDERED that the time deadlines of R14-2-1103 shall be extended 180 days.
