Level 3 Communications ("Level 3") requests additional time to file exceptions to the Recommended Opinion and Order ("ROO") filed in this docket. Presently, the ROO is scheduled to be heard at the May 2, 2006 Open Meeting with exceptions due on Monday, April 17, 2006. Level 3 requests an extension until April 24, 2006 to file exceptions.

In support of this motion, Level 3 states:

The ROO was issued on Friday, April 7th. Local counsel for Level 3 received the ROO in the mail on Monday, April 10th. The cover memo to the ROO required exceptions to be filed on Monday, April 17th. In effect, given the intervening weekend days and delayed delivery, Level 3 was provided only five business days to file exceptions.

Level 3 requests that the date for filing exceptions be extended until Monday, April 24, 2006. Given the number and complexity of issues addressed by the ROO and the delayed receipt of the ROO by counsel, Level 3 submits additional time for exceptions is warranted. Moreover, even if the exception date is extended to April 24, 2006, that date is still eight days prior to the
