Dear Members of the Arizona Corporation Commission,

We are residents of Gold Canyon and have been since 1997. We are residents of Arizona. Our home is in a senior community called MountainBrook Village. It is located just east of the sewage treatment plant now owned by Algonquin Power Income Fund. We would like to register our displeasure and disapproval of the proposed rate increase that company is asking for from its customers.

We understand they are asking for a rate increase more than double their present rate, from \$35 to \$70.34 per month. We know they have expanded the plant and installed some odor control equipment which has made it somewhat more comfortable to live near there, but we were assured by their management that the expansion and improvements would not increase our rates, but that the costs would be borne by hook-up charges from new customers.

We do not understand why the change in plans, but most all of us are retired and cannot go out and earn more money as our costs rise. Therefore we are asking you to reject their proposed rate hikes and keep the cost per home the same as it is. It is already much higher than most homeowners in other communities are paying.

We are Mountainbrook Village home owners writing in hopes of preventing a proposed increase in our sewer rate.

The present rate of \$35/mo is in the option of many here at MB too excessive for this service and any increase above this amount to be greatly unjust and calls for help from our elected officials to see that it doesn't happen.
