

NOTIFICATION OF NAME DETERMINATION

On April 18, 2003, pursuant to Executive Order No. 10485, as amended by Executive Order No. 12038, Section 202(e) of the Federal Power Act ("FPA"), 16 U.S.C. § 824a(e) (2000), and Section 320, *et seq.*, of the Rules of Administrative Procedure of the Department of Energy ("DOE" or "Department"), 10 C.F.R. § 205.320 *et seq.* (2002), Citizens Communications Company ("Citizens") and UniSource Energy Corporation ("UniSource Energy") jointly tendered for filing two applications with the Department. The applications for the presidential permits and export authorizations were the result of an asset purchase agreement, dated October 29, 2002, whereby Citizens agreed to sell, and UniSource Energy agreed to purchase, all of the assets (subject to certain stated exceptions) used by Citizens in connection with or otherwise necessary for the conduct of Citizens' electric utility business in Arizona (the "Transaction"). On May 21, 2003, the Federal Energy Regulatory Commission authorized the Transaction. *Tucson Electric Power Co., et al.*, 103 FERC ¶ 62,100 (2003). In addition, on July 3, 2003, the Arizona Corporation Commission approved the Transaction. *In the Matter of the Joint Application of Citizens Communications Company and UniSource Energy Corporation*, Decision No. 66028, ACC Docket Nos. E-01933A-02-0914, E-1032C-02-0914, and G-01032A-02-0914 (2003).

In the first application, UniSource Energy and Citizens requested that the Department rescind Presidential Permits 16<sup>1</sup> and 40<sup>2</sup> ("PP-16" and "PP-40", respectively) held by Citizens covering certain transmission facilities, that currently interconnect Citizens' electrical system in Arizona with Mexico and to coincidentally reissue Presidential Permits to NewCo, a subsidiary of UniSource Energy, covering these same Interconnection Facilities to become effective upon the financial closing of the transfer of ownership of Citizens' Arizona electrical system to NewCo. In the second application, Citizens and UniSource Energy requested that the Department rescind Citizens' export authorities to transmit electric energy from the United States to Mexico and simultaneously reissue export authorities to NewCo, a subsidiary of UniSource Energy, without energy limits to become effective upon the financial closing of the transfer of ownership of Citizens' Arizona electric system to NewCo.

As explained in both applications, the name of UniSource Energy's subsidiary had not yet been determined. Accordingly, for purposes of the applications, UniSource Energy's subsidiary was designated "NewCo." UniSource Energy indicated that it would promptly notify the Department in writing of the official name of this entity when a final determination was made.

<sup>1</sup> The facilities to be covered when PP-16 is reissued consist of:

A three-phase distribution line operating nominally at 13 kV, 60 cycle, located at the international boundary between the State of Arizona and the State of Sonora, Mexico, crossing the international boundary west of the intersection of Sonoita Avenue and West International Street at the international boundary in Nogales, Arizona, located at 486 West International Street.


This description has been updated from the April 18, 2003 application to reflect the removal of the 2.3 kV line as described therein.

<sup>2</sup> The facilities to be covered when PP-40 is reissued consist of:

A single circuit, three phase, 60 cycle, 13.2 kV electrical transmission line crossing the International Boundary 1,540 feet east of Boundary Monument No. 112, Section 21, Township 24 South, Range 17 East in Lochiel, Arizona. The line has a capacity of 4 MW.

UniSource Energy hereby formally notifies the Department that the official name of this entity (formerly referred to as "NewCo") is UNS Electric, Inc. As a result, UniSource Energy respectfully requests that the applications filed in the above referenced dockets for the rescission and simultaneous reissuance of Presidential Permits and the rescission and simultaneous reissuance of export authorities be considered and approved to become effective upon the financial closing of the transfer of ownership of Citizens' Arizona electrical system to UNS Electric, Inc.


