

Should testimony be pre-filed, the City requests that this testimony be filed by Wednesday, May 17, 2006, to allow the City time to review and prepare for the hearing. Should West End Water Company not be required to pre-file testimony, the City requests that West End Water

Company, Staff and the City of Surprise be required to provide by Wednesday, May 17, 2006, notice to all parties of witness who will appear at the hearing and the subjects upon which they will testify.
