PROCEDURAL ORDER

BY THE COMMISSION:

On March 10, 2006, Time Warner NY Cable ("TWN"), Time Warner Cable Information Services (Arizona) LLC dba Time Warner Cable ("TWCIS") and ACC Telecommunications, LLC ("ACC") filed with the Arizona Corporation Commission ("Commission") an application for expedited consideration requesting that the Commission consent to the proposed assignment from ACC to TWNY, and immediately thereafter, to TWCIS, of existing customer contracts and related assets of ACC used in connection with the provision of intrastate telecommunications services in Arizona.

On May 17, 2006, the Commission's Utilities Division ("Staff") filed its Staff Report recommending approval of the application with conditions.

TWCIS does not have a Certificate of Convenience and Necessity in Arizona.

A Procedural Conference should be held to allow the applicants and Staff to discuss an appropriate procedural means of processing the application.
