



NOTICE OF HEARING
A PUBLIC HEARING WILL BE HELD before the Arizona Power Plant and Transmission Line Siting Committee ("Committee") regarding the Application of Southern California Edison Company ("SCE") for a Certificate of Environmental Compatibility authorizing the Palo Verde Hub to Devers No. 2 500kV Transmission Project ("Project") in Maricopa County and Yuma County, Arizona. The hearing will be held at the Wigwam Resort, 300 Wigwam Blvd., Litchfield, Park, Arizona, beginning on June 26, 2006 at 9:30 a.m. and continuing on June 27, 2006, at 30 a.m. The hearings will adjourn at approximately 5:00 p.m. Additional hearing days, if necessary, will be noticed on the Project and Arizona Corporation Commission ("ACC") websites.

The Project website is www.sce.com/powerandenvironment/goalsandimprovements/dpv2. The ACC website is www.cc.state.az.us/utility/electric/linesiting-calendar.htm. Public comment will be taken at the beginning of each hearing day. Public comment also will be taken in a special evening session on June 26, 2006 beginning at 6:00 p.m. at the Wigwam Resort, 300 Wigwam Blvd., Litchfield Park, Arizona. The Committee may conduct a tour of the Project area, proposed route and sub-alternate route on a future date. The map and itinerary for the tour will be available at the hearings and posted on the Project website. Members of the public may follow the Committee in their own private vehicles. During any tour, the Committee will not discuss or deliberate in any manner concerning the Application.

A general location map of the Project study area, Applicant's proposed Route and Alternative Routes are set forth below.

Proposed Route
The Arizona portion of the Project would consist of the construction of 102 miles of 500kV transmission line from the Harquahala Generating Station Switchyard (Line Siting Case No. 128) to the Colorado River, as illustrated in Figure 1. The transmission line would exit the Harquahala Generating Station switchyard located in Maricopa County, Section 31, Township 2 North, Range 8 West and parallel the existing Harquahala-Hassayampa 500kV line (Line Siting Case No. 96) in an easterly direction for approximately 5 miles within a 1,000-foot-wide corridor centered on the existing line.

The remainder of the Project would be located within a nominal 100-foot-wide right-of-way on BLM and state land and a nominal 100-foot wide right-of-way on private land adjacent to the existing Devers to Palo Verde No. 1 500kV transmission line ("DPV1") (Line Siting Case Nos. 34 and 48) right-of-way. The Project right-of-way will be to the west and south of the DPV1 right-of-way of Copper Bottom Pass, and on the east and north side of the DPV1 right-of-way between Copper Bottom Pass and the Colorado River.

At a point 5 miles east of the Harquahala Generating Station where the route meets the DPV1 transmission line, the route would then turn north and parallel DPV1 for approximately 2.7 miles to Interstate 10 ("I-10"), where it would cross I-10 and proceed to a point 1 mile northwest of Burnt Mountain. The route would then turn west and roughly parallel the I-10 and Central Arizona Project ("CAP") Canal for approximately 20 miles through the Big Horn Mountains and across the Harquahala Mountains to a point 0.5 mile north of I-10. The route would then turn southwest, crossing I-10, and proceed approximately 5 miles to intersect the El Paso Natural Gas Company's existing pipeline north of its Wenden Pump Station north of the Eagletail Mountains. The route would then parallel the El Paso Natural Gas pipeline and DPV1 line for approximately 56 miles, crossing the Ranegras Plain, through approximately 25 miles of the Kofa National Wildlife Refuge ("NWR"), La Posita Plain, and Arizona State Highway 95, through the Dome Rock Mountains to the summit of Copper Bottom Pass. The route would then turn southwest away from the pipeline, descending the western slope of the Dome Rock Mountains and proceed approximately 10 miles to a crossing of the Colorado River in La Paz County, Section 5, Township 2 North, Range 22 West.

An additional interconnection option is to originate the line at a new Harquahala Junction Switchyard (Line Siting Case No. 128) located in the southwest quarter of Section 25, Township 2 North, Range 8 West rather than at the Harquahala Generating Station Switchyard. If this interconnection option is used, the Applicant will not construct the 5 miles of 500kV line parallel to the existing Harquahala-Hassayampa 500kV line.

Harquahala-West Subalternate Route

Station Switchyard directly to the west for 12 miles within a 1,000-foot-wide corridor centered on section lines, beginning on the section line between Sections 30 and 31 in Township 2 North, Range 8 West, and ending at the section line between Sections 29 and 32 in Township 2 North, Range 10 West. This subalternate route would then follow the El Paso Natural Gas pipeline corridor-northwest for 9 miles to its intersection with the Proposed Route. This portion of the subalternate route would be located in a designated BLM utility corridor within a 130-foot-wide right-of-way adjacent to the north of the existing pipeline right-of-way.

Palo Verde Subalternate Route

The Palo Verde Subalternate Route would originate at the Palo Verde Nuclear Generating Station ("PVNGS") Switchyard (Line Siting Case Nos. 22 and 24) in Maricopa County, Section 34, Township 1 North, Range 6 West, rather than at the Harquahala Generating Station Switchyard. This alternative would require the construction of an additional 10 miles of 500kV transmission line parallel to the DPV1 transmission line on the east and north of the DPV1 right-of-way to the PVNGS switchyard. The majority of this alternative will be within a BLM designated corridor. More complete maps, along with more detailed textual descriptions of the proposed and alternative alignments are available in the Application itself and on the Project website. 


