PROCEDURAL ORDER

BY THE COMMISSION:

In Decision Nos. 68071 and 68072, the Arizona Corporation Commission ("Commission") authorized rate increases for the Arizona Electric Power Cooperative, Inc. ("AEPKO") and Southwest Transmission Cooperative, Inc. ("SWTC"), respectively. Decision Nos. 68071 and 68072 required AEPKO and SWTC to file Equity Management Plan Analyses by March 31, 2006.

By Procedural Order dated April 6, 2006, the Commission extended the deadline for filing the Analysis until May 31, 2006. AEPKO and SWTC had requested extra time because other regulatory matters had delayed completion of the Analysis.


On May 24, 2006, AEPKO and SWTC filed a second request to extend the deadline to June 16, 2006. AEPKO and SWTC state that they have completed the Analysis, but not in time for their Boards of Directors to review the filings prior to their May meeting. Both boards are scheduled to meet on June 13 and 14, 2006, at which time they will review the Analysis.

Staff does not object to the extension.
