**MOTION TO INTERVENE
OF
CP WATER COMPANY**

CP Water Company, an Arizona public service corporation, hereby moves the Arizona Corporation Commission (“Commission”) for leave to intervene in the above-captioned proceeding pursuant to A.A.C. R14-3-105. This motion is supported by the following facts and information:

1. On March 29, 2006, Arizona Water Company (“AWC”) filed with the Commission an application (the "Application") to extend its existing Certificate of Convenience and Necessity (“CC&N”) to provide public water utility service within the City of Casa Grande and various parts of Pinal County, Arizona (collectively, the “Extension Area”). The Extension Area is described in Exhibit 1 to the Application, and is depicted on the map attached as Exhibit 2 to the Application.

1 2. In a Procedural Order dated April 25, 2006, the Commission consolidated Docket
2 W-01445A-06-0199 with Docket Nos. SW-03575A-05-0926 (Palo Verde Utilities Company)
3 and W-03576A-05-0926 (Santa Cruz Water Company).

4 3. The Extension Area includes certain property which is located within the CC&N
5 of CP Water Company. Maps depicting the CC&N of CP Water Company are attached hereto as
6 Attachment "A." CP Water Company has not consented—nor does it consent—to the transfer of
7 any portion of its CC&N to AWC, and objects to the inclusion of its certificated territory in the
8 Extension Area. CP Water Company is directly and substantially affected by these proceedings.

9 4. The granting of intervenor status to CP Water Company will not delay this
10 proceeding or cause the issues to be unduly broadened.






