





RE: NEW RATES EFFECTIVE APRIL 1, 2006

Duncan Rural Service Corporation ("DRSC") is the local gas distribution delivery service provider. As such, we purchase gas through the El Paso Pipeline and deliver it to you through our distribution system in DRSC's service territory.

On May 2, 2005, DRSC filed a request with the Arizona Corporation Commission (ACC) for a revenue increase of \$200,250 or 31% to cover the higher cost of gas caused by the nationwide increase in natural gas prices as well as increases in other expenses and plant improvements. After considering the DRSC's case and the ACC Staff's analysis, the ACC issued Decision No. 68599 on March 23, 2006 reducing the proposed revenue increase to \$167,705 or 26% and approving new rates for DRSC's use in calculating customers' bills for all gas usage effective on and after April 1, 2006.

The following table shows estimated winter customer bills with and without the authorized rate change depending upon the monthly gas usage. These amounts do not include sales tax.
