



Eight 9 Line, L.L.C. has filed with the Arizona Corporation Commission an application for a Certificate of Convenience and Necessity to provide competitive resold interexchange toll telecommunications services in the State of Arizona. Applicant will be required by the Commission to provide this service under the rates and charges and terms and conditions established by the Commission. A.R.S. 40-282 provides that the Commission may act on an application for a Certificate of Convenience and Necessity to provide resold telecommunications services without a hearing, or with a hearing, if one is requested by any party. Intervention shall be in accordance with A.C.R. 14-2-15, except that all motions to intervene must be filed on or within twenty (20) days of the date of this notice.
