Dear Mr. Clay:

According to Arizona Corporation Commission ("Commission") records, you and/or your Company/Firm are the representative for the reseller applicant indicated above. Commission Staff sent a letter in January 2000, notifying applicants that their Application for a Certificate of Convenience and Necessity ("CC&N") to resell telecommunications services within the State of Arizona would be processed. A request for updated information was made in the letter.

The purpose of this letter is to send a final notification, to the last known representative's address on record, to determine if the above referenced company wishes to have its application processed. If so, you must provide the following updated information: the current name of the company; whether the company is doing business and continues to do business in Arizona; accurate names of contact people in the company; and current and accurate company addresses, telephone numbers, and e-mail addresses if available.

All updated information (*i.e.* amendments to the original application) must be mailed to: Docket Control Center, Arizona Corporation Commission, 1200 West Washington, Phoenix, Arizona 85007. An original and 10 copies are required. Please include the company's docket number on all documents. Dockets cover sheet and filing instructions can be obtained from the Docket Control Center (602-542-3477).

If the reseller applicant no longer wishes to have its application processed, a Request to Withdraw form is also available from the Docket Control Center. Please complete the form, and send the original and 10 copies of the form to the Docket Control Center.

If your response is not received by October 23, 2000, as the last known representative on record for the reseller applicant, the pending application will be dismissed and the docket administratively closed. **Be advised that the legal consequence of dismissal or withdrawal of the company's application, is that the company will no longer have the authority to resell telecommunications services within the State of Arizona and must cease all business activity involving resold telecommunications services in Arizona.**
