RE: STAFF REPORT FOR JAMES EUTSEY DBA A J LAUNDROMAT APPLICATION TO CANCEL A CERTIFICATE OF CONVENIENCE AND NECESSITY FOR CUSTOMER OWNED PAY TELEPHONE (DOCKET NO. T-03922A-01-0981)

On December 17, 2001, James Eutsey dba A J Laundromat ("Applicant") filed an application to cancel its Certificate of Convenience and Necessity ("CC&N") for a customer owned pay telephone ("COPT"). The Applicant indicated in its application that it no longer provides COPT service in the State of Arizona. Therefore, Staff recommends that the Applicant's application be approved.

Staff confirmed that the Applicant is not requesting authority to sell its COPT assets. Staff verified that the Applicant gives up its right to a hearing and to receive notice of a hearing date to cancel its CC&N. Also, the Applicant acknowledged that he is authorized to make the application for the cancellation of the CC&N for COPT.

Staff recommends that the Applicant's application be approved without a hearing. Upon cancellation of its CC&N, James Eutsey dba A J Laundromat will not be authorized to provide COPT telecommunications services in Arizona and will not have to meet the requirements of Decision No. 63520.
