ORDER

BY THE COMMISSION:

12 Having considered the entire record herein and being fully advised in the premises, the
13 Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

14 **FINDINGS OF FACT**

15 1. James Eutsey dba A J Laundromat ("Applicant") has a Certificate of Convenience and
16 Necessity ("Certificate") to provide customer-owned pay telephone ("COPT") service in the State of
17 Arizona pursuant to Decision No. 63520 (March 30, 2001).

18 2. On December 17, 2001, Applicant filed with Docket Control of the Commission an
19 application for approval of the cancellation of the Certificate, indicating that it no longer provides
20 COPT service in the State of Arizona.

21 3. On July 11, 2002, the Commission's Utilities Division Staff ("Staff") filed a Staff
22 Report, recommending approval of the application to cancel Applicant's Certificate without a
23 hearing.

24 **CONCLUSIONS OF LAW**

25 1. Applicant is a public service corporation within the meaning of Article XV of the
26 Arizona Constitution and A.R.S. §§ 40-281 and 40-282.

27 2. The Commission has jurisdiction over Applicant and the subject matter of the

2 3. The cancellation of Applicant's Certificate is in the public interest.

3 4. Pursuant to A.R.S. §40-282, the Commission may issue Decisions regarding COPT
4 Certificates without a hearing.

5 5. Staff's recommendation in Findings of Fact No. 3 is reasonable and should be
6 adopted.

7 **ORDER**

8 IT IS THEREFORE ORDERED that the application of James Eutsey dba A J Laundromat for
9 the cancellation of the Certificate of Convenience and Necessity to provide customer-owned pay
10 telephone service shall be, and is hereby, approved.

11 IT IS FURTHER ORDERED that this Decision shall become effective immediately.
