ORDER

BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. Lubbock Radio Paging Services, Inc. dba Stenocall ("Applicant") has a Certificate of Convenience and Necessity ("Certificate") to provide alternative operator service ("AOS") service in the State of Arizona pursuant to Decision No. 58511 (January 13, 1994).
2. On March 21, 2001, Applicant filed with Docket Control of the Commission an application for cancellation of the Certificate, indicating that it no longer provides AOS service in the State of Arizona.
3. On July 16, 2002, the Commission's Utilities Division Staff ("Staff") filed a Staff Report, recommending approval of the application to cancel Applicant's Certificate without a hearing.

CONCLUSIONS OF LAW

1. Applicant is a public service corporation within the meaning of Article XV of the Arizona Constitution and A.R.S. §§ 40-281 and 40-282.
2. The Commission has jurisdiction over Applicant and the subject matter of the

1 application.

2 3. The cancellation of Applicant's Certificate is in the public interest.

3 4. Pursuant to A.R.S. §40-282, the Commission may issue this Decision without a
4 hearing.

5 5. Staff's recommendation in Findings of Fact No. 3 is reasonable and should be
6 adopted.

7 **ORDER**

8 IT IS THEREFORE ORDERED that the application of Lubbock Radio Paging Services, Inc.
9 dba Stenocall for the cancellation of its Certificate of Convenience and Necessity to provide
10 alternative operator service shall be, and is hereby, approved.

11 IT IS FURTHER ORDERED that this Decision shall become effective immediately.
