Dear Commissioners,

Although your decision process for the APS proposed rate hike may be complete at this juncture, I feel it is important to share with you the level of commitment they have demonstrated to arts organizations over the years. Perhaps this information will be beneficial in future decisions pertaining to APS. When Chandler Center for the Arts opened in 1989, APS awarded \$40,000 to subsidize artist fee expenses, which helped to launch our inaugural season. In 1998, APS provided \$20,000 to fund our first family series, which afforded families an economical means of experiencing live cultural events together. APS has continued to support our family series over the years, which has provided an ongoing discount pricing structure that draws families to the Center who might otherwise be unable to participate in the arts. APS has also funded such arts organizations as the Phoenix Symphony, Ballet Arizona, Arizona Opera, Arizona Theatre Company, the Heard Museum, Scottsdale Cultural Council and dozens more. I might add that in 2006, APS was nominated for the Governor's Arts Award in the Corporate category. Additionally, they received the Business-Arts Award at our 2006 endowment benefit event in recognition of their longstanding funding support of the Center.

Arizona is one of the lucky few states to have a regulatory agency such as the Corporation Commission to
