PROCEDURAL ORDER

BY THE COMMISSION:

On October 25, 2005, the Arizona Corporation Commission ("Commission") issued Decision No. 68243 which granted to Santa Rosa Water Company ("SRWC") and Santa Rosa Utility Company ("SRUC") Certificates of Convenience and Necessity ("Certificates") to provide water and wastewater water service, respectively.

On April 14, 2006, SRWC filed a request for extension of time until October 25, 2007, to file its Certificate of Assured Water Supply ("CAWS") stating that significant efforts are being made to obtain the CAWS including the acquisition of approval of an Analysis of Assured Water Supply from the Arizona Department of Water Resources.

On April 25, 2006, the Commission's Utilities Division ("Staff") filed a memorandum stating it had no objection to the request for extension of time.

Accordingly, the request by SRWC for an extension of time should be granted.


