APPLICANT'S NOTICE OF HEARING WITNESSES

Pursuant to the Procedural Order of May 12, 2006, the Applicant hereby provides notice of the witnesses it intends to call at the hearing on the Application:

Marvin Collins (Manager, West End Water Company): Mr. Collins will testify in support of the Application. Mr. Collins will testify with respect to his qualifications, expertise, and current employment. He will also testify to confirm and adopt as part of his testimony the facts of which he has personal knowledge contained in (1) the Application, (2) the Applicant's Response to the Staff Report, and (3) facts relative to WEWC contained in the Applicant's Response to the Filed Testimony of Intervenor Surprise. Mr. Collins will also testify with respect to the Applicant's customer services available to customers, including, but not limited to, a website with on-line

1 payment options and system reliability. He will testify that WEWC would prefer to
2 provide wastewater treatment services within its service area. To such end, Mr. Collins
3 will testify that he is a licensed wastewater operator in the State of Arizona with recharge
4 and re-use experience. Mr. Collins will also testify with respect to the WEWC Master
5 Plan and the Applicant's efforts and results with respect to the water loss issue.

7 **Ray L. Jones, PE (President, Aricor Water Solutions):** Mr. Jones is an
8 independent contractor of WEWC, who will testify on behalf of WEWC in support of the
9 Application. He will confirm and adopt, as part of his testimony, the facts of which he
10 has personal knowledge contained in the (1) Application; (2) the Applicant's Response to
11 Staff Report; and (3) facts contained in the Applicant's Response to the Filed Testimony
12 of Intervenor Surprise. Mr. Jones will also testify with respect to his personal knowledge
13 and experience with respect to wastewater treatment and, specifically, MAG 208 Water
14 Quality Plan Amendments. He will also testify with respect to the WEWC Master Plan,
15 which he developed, including, but not limited to, the design standards and assumptions
16 that he used to develop the Master Plan. Mr. Jones will also testify as to the similarities
17 and differences between WEWC and Surprise with respect to the proposed expansion
18 area.


